ENTRANCE FEE: \$15.00 per entry, limited to two entries; due with entry form. Checks should be made out to CASA

1. Exhibition is open to **ACTIVE** members only. You may enter two collages.
2. Maximum: framed or finished size: 36" x 36". Minimum: No painting less than 8" x 10" image. Any painting exhibited in any other CASA show may **NOT** be entered; work must not be older than two years.
3. All work must be original two- or three-dimensional, mixed media glue collage (at least 50 percent collage), and completed within the past two years.
4. Framing: Plexiglas only—**NO GLASS**. No saw tooth type hangers. Use simple framing, nothing ornate. Canvas Collages must be finished on all sides. A collage, not suitably framed or finished, will be rejected.
4. All work must be for sale. Price nothing under \$100.00.

COMMISSION: 20 percent on all sales to be handled through the gift shop.
