1. Exhibition is open to **ACTIVE** members only. You may enter two collages. Maximum size 18" x 24".
2. All work must be original two- or three-dimensional, mixed media glue collage (at least 50 percent collage), and completed within the past two years.
3. Framing: Plexiglas only—**NO GLASS**. No saw tooth type hangers. Use simple framing, nothing ornate. Canvas Collages must be finished on all sides. A collage, not suitably framed or finished, will be rejected.
4. **ARTIST MUST BE AVAILABLE FOR DOCENT WORK. SIGN UP FOR WORKING WEDNESDAY THROUGH FRIDAY.**
