2. All work must be original two- or three-dimensional, mixed media collage produced in the last two years.
3. Framing: Plexiglas only – **no glass**. No saw tooth hangers. Canvas collages must be finished on all sides. Use simple frames, nothing ornate.
4. CASA reserves the right to refuse an entry that does not conform to the regulations or which is soiled, poorly framed, or too fragile to be safely displayed.

COMMISSION: no commission on sales.

ACCEPTED ARTWORK MUST BE DELIVERED TO: Northern Trust Bank on October 5, 2010, at 9:00am

Date of jury: Friday, September 10, at Streams in the Desert Lutheran Church (regular meeting date) at 9:30am

Date of pickup: January 4, 10:00am at Northern Trust Bank
